BOARD OF DIRECTORS MEETING

November 13, 2019

Cooper called the meeting to order at 10:00 a.m.

Cooper asked if the Board had issue with the agenda, noting none, confirmed consensus of the Agenda.

CHAIR REPORT

Cooper reminded the Board this is our last meeting for the year. The Finance Committee and Board will meet again in January.

PUBLIC COMMENT

There were no public comments.

CONSENT AGENDA

Cooper asked approval of the Consent Agenda. Brotherton moved approval of the Consent Agenda. The motion was seconded and carried unanimously.

PUBLIC HEARING

Rule 1.11 – Federal Regulations Reference Date change

R. Moody noted this is our annual amendment to our regulations. The intent is, as the federal rules

are updated, we also adopt the most recent version of the rules we have identified in our regulations. This rule change will update the date to July 1, 2019, as well as remove the date from Appendix A, as it is unnecessary. We also corrected a few typographical errors in the Appendix. We have received no comments, R. Moody noted.

Cooper opened the public hearing at 10:04am. There were no comments and Cooper closed the hearing at 10:04am.

Neatherlin moved to approve the proposed changes to Rule 1.11 and the Appendix A as presented. The motion was seconded and carried unanimously.

NEW BUSINESS

Policies and Procedures Manual - updates

McNair noted the draft had been sent out via email and she stated she didn't get any comments. McNair did state there were several grammatical updates, as well as some changes to make policies clearer. McNair stated she could go over the more substantive changes or answer questions.

Brotherton noted, overall, the improvements were logical, however he did ask why, under *Non-Solicitation* it states staff may post and view items during non-work hours. Why is it so explicit? McNair explained this is for staff to post or view items that other staff may be selling for personal/school fundraiser type items. We expect staff to view these items during their break or lunch.

Under the *fragrance-free* section, Brotherton noted, we are now allowing fragrances. McNair stated, no, we still request no fragrances, but we wanted to make sure our office is using the right kinds of cleaning products and to make sure people are aware that some people have potential issues with fragrances. We removed the initial sentence, McNair stated, because we felt it was duplicative after clarifying the section. Cooper asked why tobacco isn't included as an odor problem. McNair explained we deal with tobacco in a different section. There was some discussion and no changes were made to that section.

Menser asked, under *Code of Ethics*, why did we strike out the identity of, contact information, etc. for customers and vendors. McNair stated it is public record and we would have to release it. Myers explained we don't want to have a general statement that includes a broad category. There may be parts of this category that are exempt, but the PRA would cover that.

Menser added he had found a few grammatical or typographical issues and gave his marked copy to McNair for incorporation. He specifically noted *Fringe Benefits* - ..wellness reward provided by ORCAA *is* subject to federal...if the reward *does* not... he felt it should be do instead of does. Under *Compensatory time*-...receive *advanced* approval...he felt should be *advance*.

Pratt moved approval of the policy manual with the changes proposed by Menser. The motion was seconded and carried unanimously.

McNair noted we will be coming back next year with some proposed changes on our purchasing policy.

Cooper asked the Board if they are comfortable with staff writing and proposing the policies, or, do we want to have a different role in the process. The Board was ok with the current process.

DIRECTORS REPORT

Compliance Program Update

R. Moody explained in the complaint section you will notice we have been getting involved with homeless camps. We are working with the city of Olympia, the Fire Department, and the county to some extent, in trying to get burning issues resolved. The Jungle is near the IT facility and they are burning and causing smoke issues for the IT employees. Cooper did note it is a difficult situation because it is private property.

McNair did note we are having a hard time getting in touch with one property owner. The other is working with both the city and us. Winborn questioned what can be done? R. Moody explained the tools we have to work with, don't really fit these types of situations. We are working with the city and county to try to work on solutions. McNair explained at this time the only thing we can do is issue a notice of violation to the property owners. There was some discussion regarding options. There was no action required of the Board.

Neatherlin noted he had a question regarding a fine issued to Roisum, wondering what did they do? R. Moody explained the party was bringing trailer loads of material to a property, dumping the debris (garbage, mattress, etc.) and burning it.

Engineering Program Update

Goodin explained things have slowed down for his group, which is typical this time of year. Goodin did note there are quite a few gasoline facility amendments that have been finalized, and if there are any cases you'd like information on, just ask.

Air Quality Program Update

Hadley stated October is a transitional month for air quality. We are beginning to see a slight increase in numbers due to burning, both indoors and out. We are also beginning to see peaks in our Mason County Saturation Study. Hadley noted the sites are still correlating with each other and none of them stick out as being a particularly bad player.

Ozone season is over, Hadley explained, however, we will continue to monitor. Ecology did an audit of our Cheeka Peak site in October. Hadley noted Grant has spent some time up north working on some communication issues and a QC at Port Townsend. Hadley noted the American Association for Aerosol Research conference was held in Portland and she did attend and presented our community toxics work. The students also attended and presented their work, Hadley added. Hadley did note the student posters are hanging on the wall.

Cooper stated he has read several articles regarding degrading air quality nationally, based on EPA policy. Do we have a local response or write-up that tells any story? Hadley noted that is on a national level and she doesn't know how it is affecting us locally. Hadley added she isn't seeing anything, specifically, in the ambient air. McNair added the feds may be loosening up things in certain areas, our regulations allow us to be more stringent. We will continue the path we are on and hope to see improvements. (Neatherlin left at 10:50am)

Education and Outreach

Nelson explained it is burn season and we have been getting in a lot of Thurston County Residential Burn Permits. The good news is we have received about ½ the number of invalid

permits as last year. Nelson noted this means, people are starting to learn where and when they can burn. Our woodstove program is going well. Nelson noted we have paid out \$40,000 and we have allocated another \$43,000. Most of the projects are in Thurston County, however, Clallam is making a strong push and we have had some contractors send in their vendor forms. Mason County PUD has been sharing the information, word is getting out and we are hopeful to see some applications coming in.

Nelson stated he and McNair have sat in on some homeless taskforce meetings. We do get a lot of calls regarding burning in homeless camps and we only deal with air quality issues. We continue to do our best to educate people.

Menser reminded staff and the Board he had been asked to talk to the county about standardizing the UGA rules with the cities. Menser noted he was interested in the concept; Commissioner Edwards was not interested, and Commissioner Hutchins did not express an opinion. Menser suggested the idea be brought before TRPC, however, there wasn't a lot of support from the commissioners.

McNair added there was legislation, last year, that allows for silvicultural burning in the UGA for prevention of wildfires. We were under the impression it would be a year away before it was implemented, however it appears it will be much sooner. We have been assured by DNR that they will let us know each time they will be burning.

Cooper suggested the Board or staff write up a formal request to send to the commissioners regarding burning in the UGA. Menser did state the commissioners would react to a formal request. There was concern from some members this is more of a county issue than an ORCAA issue. After some discussion, it was decided to trust the staff and let them decide whether we should act on this. McNair did note, it really is a land use issue and not an air quality issue. Cooper asked the staff bring back their decision to the January meeting.

Finance/Administrative Update

Harding noted we should be at 34% of our budget, year-to-date, and we are doing well. We have collected about 44% of our revenues and have spent right around 34% of our budget authority. We will have a second quarter update in January. Harding stated we are currently fully leased; however, we will have a vacancy in December.

Harding reminded the Board staff was asked to provide a maintenance plan. We are currently working on it and will bring it to the Finance Committee in January. Harding added, we will pay off our building in December 2022 which will allow us to work on some of the maintenance items we are considering. Currently we bring in \$61,000 with our rents and our expenditures are \$78,000. For our own space, we are paying \$3.61 per square foot.

We did have our Department of Retirement audit in October. We have been told we won't receive an official letter, but we did receive an email saying we are in compliance.

Harding mentioned staff recently attended webinars regarding identity theft and cybersecurity. We are working on training staff and our IT staff reminds staff to be vigilant with regards to email and links. One thing we learned, Harding stated, is we have identity theft coverage through our insurance Enduris. This coverage is also extended to the directors of our agency, as well as spouses, partners, children, etc. The Board and your family are included in this coverage.

Executive Director's Report

McNair congratulated Cathey for being re-elected to the council. McNair explained she is aware the councils and commissioners will be deciding who will be assigned to our Board and she noted it would be great if the current members returned. McNair stated we feel you have been a great Board and we appreciate you all.

The homeless situation has been a major portion of our work recently, McNair explained. We will continue working with the cities. McNair noted she will be attending the Air Directors' meeting and will be discussing the DNR burning in UGAs. McNair added she will also be attending a Region 10 meeting to discuss items that impact all four states.

There is discussion, on the national level, McNair explained, regarding woodstoves. They are looking at phasing in higher standards for woodstoves, starting in May of 2020. EPA noted there are vendors who have older models that may not meet the standards and the question, or discussion, is around whether they will be able to sell the older models. McNair did note this isn't a problem for our state as we are already regulating the stoves.

GOOD OF THE ORDER

Cooper wanted to share the city of Olympia was authorized to refinance several bonds and we will be going from 6% to 2%. Cooper also wanted to note, we have had a lot of conversations regarding homelessness and if any of the other members would like to come to Olympia to see what we are doing, that is going well, you are welcome.

ADJOURNMENT

The meeting adjourned at 11:36 a.m.





Proposed Changes to Saturation Study Format

- Last year we replaced optical particle counters (OPC) with Purple Air Sensors
 - Produces similar data quality
 - Easier to install
 - More flexibility in site location
- Propose to place one Purple Air next to each county air monitor
 - Use community sensors to conduct saturation studies where possible
 - Supplement with additional ORCAA owned sensors as needed
 - Provide community members/citizen scientists on-line guidance and air quality conversions based on real time correction factors
- Create mutually beneficial partnership with the community
 - Public has more control where monitors are located
 - ORCAA can use data to assess how representative our monitors are of each airshed
 - Saturation studies become permanent fixture in all counties
 - ORCAA can more quickly identify problems and respond to emergent monitoring needs
